Decree No. 732-HQLC

Regarding the Cross-Realm Licensing of Official Hogwarts Quidditch League Merchandise under the collaboration of Quality Quidditch Supplies and New Era Cap Company

In accordance with the provisions set forth by the Wizengamot's 2025 Diversity in Magical Markets Initiative under the Unified Magical-Muggle Cultural Exchange Charter, the Department of Magical Commerce and the Regulation of Magical Goods Bureau, in conjunction with the Department of Magical Artifacts and Cultural Preservation, the Department of Magical Games & Sports, the Department of Muggle Affairs, and the Department of Magical Cooperation; hereby issues this formal decree granting conditional approval to the collaboration between Quality Quidditch Supplies and muggle apparel brand New Era Cap Company, supervised by the Hogwarts Quidditch League Committee. It is with cautious optimism and unprecedented enthusiasm that the Ministry of Magic endorses this coalition to release the Hogwarts Quidditch League Collection and the House Pride Collector's Edition to the public, magical and muggle alike. The headwear in question has undergone rigorous inspection by certified charm auditors and has been deemed non-hazardous to all populations, magical or non-magical, under standard use conditions. The enchantments used in the aforementioned headwear are minor and designed only for atmospheric flair (e.g. wind-resistant stitching, mood-adaptive hues, and imperceptible charm-thread embroidery).

Section I: Hogwarts Quidditch League Collection
